Part A:

Context: The 'Poshan Tracker' has been rolled out by the Ministry of Women and Child Development, Government of India on 1st March 2021 through National e-Governance Division (NeGD), MyGov as an important governance tool. Technology under Poshan Tracker is being leveraged for dynamic identification of stunting, wasting, under-weight prevalence among children and last mile tracking of nutrition service delivery via real time data with analytics.

Problem: You are required to understand the Poshan tracker dashboard (link 2) and suggest improvements in the context of the nutrition ecosystem and usability for stakeholders (district administrative officials, anganwadi supervisors). **(word limit 2000)**

2. Explain 1-2 points in detail by creating a mock up using a tool of your choice
