Question 1: Policy Update

Client and Issue Brief: You are working as part of a public policy consulting team providing advice to a global pharmaceutical player with an interest in the Indian market. The pharmaceutical company, Company T, is particularly interested in the subject of anti-microbial resistance (AMR) in India, and in the long-run, would like to advocate for the creation of policies to help curb this.

Antimicrobial resistance (AMR) has been identified as a silent pandemic. While AMR is a natural process, its build-up can be accelerated due to overconsumption of pharmaceuticals like antibiotics, misuse in the agriculture, livestock, and poultry sector, and discharge of untreated effluents from industrial units and pharmaceutical manufacturing units.

Background and context: On a fortnightly basis, we share a policy tracker with our clients. This helps them keep abreast of policy developments and news updates in the sector. The updates are not limited to policy changes/notifications but also include conversations and statements by significant public officers that may indicate the direction in which policy is headed, shocking cases that may have emerged, or anything else that you think the client should know about. They could also include possible opportunities for the company to partner or build a relationship with the government.

Question: Make a policy tracker covering the various updates related to education. For this tracker, please find a maximum of 8-10 updates (in total). A suggested format for the same is below:

ABC wants to secure its position as a credible partner to the govt, supporting its objectives and developing partnerships with stakeholders that will help in its business growth.

Question: Your job is to help identify the key stakeholders from the following segments:

- 2. State Government of Kerala (nodal and any other departments that you may deem relevant)
- 3. a few journalists/thought leaders writing on this issue (2-3)
- 4. think tanks and research organizations working on issues related to education & skilling (1-2)
- 5. Parliamentarians who have spoken on education & skilling (2-3)

Question 3: Opinion piece/newspaper article

Background and context: As part of their public policy strategy in India, they are looking to influence the public narrative around climate change and healthcare, while simultaneously, showcasing their own prowess and positioning themselves as a thought leader in the field.

The Managing Director of the organization for India has secured an opportunity to be published in the opinion section of The Indian Express on this topic.

Question: Draft a 600-800 word opinion piece for your client on the impact of climate change on public health and the leading role that the Government of India can play in recognizing this nexus and building resilient health systems.

Purpose: The purpose of this question is to test your ability to jump into unfamiliar terrain, understand the key points to be communicated, and craft a well-written argument in your favor. Thus, the opinion piece will be evaluated based on the coherence and the use of data points that strengthen the argument.
