No matter the type of lawyer you will be, you will need to develop the skills to listen to your clients and understand their constraints and bargaining powers in entering into formal and informal agreements. Furthermore, as a lawyer, you will likely be a thought leader in your firm, neighborhood or city with the power to lead discourses and shift norms. In this spirit, your bargaining powers project assignment must be completed by following these 4 steps:

<u>First</u>, you must select any one of the following workers as your hypothetical client:

- 1. Anganwadi worker [pick a particular state]
- 2. Construction worker [pick a particular state]
- 3. Factory worker [pick a particular state]
- 4. Gig worker [pick a particular platform BigBasket, Swiggy, Zomato, Ola, Uber, Zepto, Urban Company, Amazon etc.]
- 5. Contract labourer working for the municipal government [pick a particular state]

<u>Second</u>, you are required to gather and select 2-3 narrative news reports [or news video segments] or narrative accounts from other civil society reports that shed some light on the bargaining powers and constraints that your client holds while entering into labour agreements. [Given the lack of methodological training in conducting qualitative interviews, you are <u>strongly discouraged</u> from engaging in gathering primary data, and you are <u>only expected to rely on secondary</u> resources (such as news reports, conference speeches or civil society reports).]

<u>Third</u>, you must track public comments by your client's employer [state government/platform/ private contractor] or their employer's industry association to understand this party's bargaining powers, interests and constraints when employing the labourer. Also make sure to understand the State's particular priorities and concerns in regulating these employee-employer relations.

Finally, you must tie in your efforts in the first three stages of the project to write a **2000 - 2500 word essay** explaining and reflecting on the kinds of balances the varying bargaining powers and interests are presently at. **You must also highlight the challenges as well as creative possibilities for your client within the current legal frameworks and regimes [including the Codes].** You may draw upon varying literatures, course readings, course cases and class discussions to support your reflection, if necessary.

Your bargaining powers project will be graded on the basis of the following rubric:

Depth of literature review [news reports, civil society reports, academic studies, Government notifications etc.] to understand your client's and their employer's [or employer's associations'] bargaining powers	8 marks [4 - employee; 4 employer and State]
Identification of bargaining powers, "balances" and demonstrated understanding of how these are organised by legal regimes	8 marks
Highlighting creative possibilities for client within the legal regimes	4 marks
